He moves to accept the following amendments, seconded by Division 28 Lieutenant Governor Jeremiah Palma. Division 3W Lieutenant Governor Anika Adkar asks if that award is for her committee. Division 1 Lieutenant Governor Jonathan Perez answers yes. There is no further discussion and the motion carries.

Division 1 Lieutenant Governor Jonathan Perez would like to add to the Club Video Award, "*or online submission*." He moves to accept the following amendments, seconded by Division 39S Lieutenant Governor Lauren St. Clair. There is no discussion and the motion carries.

Division 1 Lieutenant Governor Jonathan Perez adds that the committee would like to add a miscellaneous section to the Code of Contest with the following, "Any reference to an "online Jotform application" will be changed to "online application on a platform approved by the District Administrator". Any reference to the "Tech Assistant" in the code will be changed to "Tech Producer". Any reference to the email address "techassistant@tokeyclub.com" will be changed to "techpro@tokeyclub.com". The Distinguished Webmaster, K-Family, and revisions made to Distinguished Website award will take effect this Key Club year." He moves to accept the following amendment, second by Division 12/22/35 Lieutenant Governor Kailey Patterson. There is no discussion and the motion carries.

Division 1 Lieutenant Governor Jonathan Perez asked for any questions. Region 12 Regional Shane Miller shares that an updated version of the Code of Contest will be uploaded to the website. Sponsorships

Chairwoman and District Governor Lilian Thai entertains a motion to adjourn the meeting. Division 1 Lieutenant Governor Jonathan Perez moves to adjourn the meeting, seconded by Division 25W Lieutenant Governor Viranda Kwok. There is no discussion and the motion carries.
